

# Eden Youth Sports Committee Approved Minutes

1. Opened Meeting at 5:44pm
2. Community input: None at this time
3. Approved previous meeting minutes
4. Fall Soccer end of the year: Nick said it was a successful year. 22 kids signed up. Hyde Park only had 7 or 8 kids sign up and they have to be transferred out. We split the kids into 2 teams of 11. The teams of 11 were manageable, but dividing the kids was difficult because of transportation. We recognize it's important to make the skills evenly distributed and make transportation easier for the parents.
  - a) Athlete Awards: Kristina made a motion to get medals for the athletes. Dan seconded. All were in favor, motion passed. Nick will order some medals tonight for the team and certificates for 3<sup>rd</sup> through 6<sup>th</sup>. Pre-k – 2<sup>nd</sup> will get soccer balls.
  - b) Coaches Awards: Katelyn Locke, Andrew Belitsos, Zach Dezotelle, Eric, Ryan Whitney, Kelly Lane, Chelsea Sheldrick, Nicholas Tetreault. Dan suggested getting soccer balls and having their teams sign them. We already have soccer balls available and will attempt to use those if they are decent enough.
5. Basketball Sign Ups and start of the year
  - a) Basketball Jerseys: Katelyn has partnered with LUHS about their system for shirts. We will be able to get the shirts at cost and get donations from local businesses as sponsors and that will allow us to put the money back into the account and cover some costs. 30 logo shirts would be 198 dollars. Each family can get a shirt as well.
  - b) Sponsorships: As mentioned above. Trevor made a motion that a sponsorship must be at least 50 dollars. Dan seconded. All were in favor. Motion passed.
  - c) Signups: A flyer has been made and sent out with a QR code for sign up. 15 athletes signed up within the first 2 days. Registration will close October 30<sup>th</sup>, and the fees will remain the same.
6. Eden Youth Sports Funds and potential investments (CD): Current balance of 22,957.12. It has been suggested to move 20k into a CD account. We all agree that it is a good idea but need more discussion. Kristina is wondering what bank this is with, Nick mentioned maybe waiting until after basketball season. We have concerns of leaving not enough with a 20k transfer. We will wait to know more information and see where the funds land after paying for basketball things.
7. Brief discussion of having the 6<sup>th</sup> grade class do concessions again.
8. Dan made a motion to adjourn meeting at 6:53pm. Trevor seconded motion. All were in favor. Meeting closed.
