1. Community Input- None at this time. Two in observance
2. Review and approve previous meeting minutes- Kristina would like to edit or amend her motion to be as follows: Kristina makes a motion to have the committee purchase uniforms/jerseys as needed. Dan seconded. All in favor.

Dan looked into bleachers and tier and length correlate with price. Dan also brought up going to the next selectboard meeting because there is a

clause that the town can buy back the property for 1 dollar. Dan will contact Dylan to get pricing 4 row, 15 foot aluminum. We will need at least 2. Dan will also contact Dylan regarding the impact mats hanging over the tables.
